2 Release Notes

A new update to the ISWC database software is planned. This will be the second production release since the go live of the new ISWC database at the end of July. The REST API definition itself has not changed. However, some fixes to business rules may cause legitimate rejections following this release where previously a technical exception or no error was raised. Agencies and hubs who directly interface with the ISWC database should consider if they need to do any testing of their integration software with this release in UAT before it is deployed to production.
