2 Release Notes

There is a release of the ISWC database software planned for Tue, 22nd Jun, @ 10:30AM CET. The expected service interruption for the production release is less than thirty minutes.

The purpose of this release is to introduce a new feature. It also contains miscellaneous minor bug fixes. This release does contain a REST API change so if you integrate directly with the REST API you should consider a quick smoke test in UAT. More details on this change are listed in section 2.4 Features below.
